EPCRA Changes - PFAS reporting under SARA 313

What you need to know about the addition of certain Per- and Polyfluoroalkyl Substances (PFAS) to the Emergency Planning and Community Right-to-Know Act (EPCRA) Section 313 Toxic Release Inventory (TRI) list. The US EPA added 172 PFAS chemicals to the TRI list in early 2020. If your facility manufactured, processed or otherwise used one of these TRI-listed PFAS at or above the reporting threshold of 100 lb during CY2020, your facility is required to prepare and submit a TRI report to your state and the US EPA by July 1, 2021 unless exempt. Potential TRI reporters should be tracking and collecting data now that covers CY2020 to enable a thorough report applicability evaluation. KEN YASS, Geosyntec

Ambient Air Modeling vs. Monitoring for PM2.5

Many project proposers have had difficulties with pre-permit PM2.5 modeling because of the conservative nature of emission factors, nearby source impacts, and background, along with tight 24-hour and annual air quality standards. States are evaluating different options for primary PM2.5 analyses, including not modeling PM2.5 at all, or using ambient monitoring data instead of modeling. This presentation offers a snapshot of different options and how to address permitting requirements with them.

Applying Accident Theory to Legal Practice

This legal ethics session will explore the impact of accident theory on legal practice. The concept is that more complex and tightly coupled systems will naturally lead to more system accidents unless appropriate measures are taken to prevent them. Research typically focuses on high risk industries such as nuclear power or aviation, but increasingly the legal field is subject to the same trends of becoming more complex and tightly coupled. This presentation will explain how the theory applies to legal practice and explore different solutions to prevent "normal accidents" in the practice of law.
