 - Strengthen enforcement, assess & reduce impacts, & meaningful & frequent engagement with overburdened communities
- Draft EPA Strategic Plan: October 1, 2021
- CEQ Proposed NEPA Regulations, October 7, 2021 2020 regulations may have curtailed EJ analysis; proposed "Effects include ... cultural, economic, social, or health, whether direct, indirect, or cumulative"
- EPA Cumulative Risk Guidance, December 2021
- Coming Soon: Climate Justice and Economic Screening Tool "CJEST"






EJ & Permitting: Putting Pen to Paper

- EPA 2021 Letters:
 - CalTrans, March: "After thoughtful consideration ... the EPA ultimately concludes that a PM hot-spot analysis is necessary for the project's transportation conformity determination."
 - Chicago Mayor, May: "EPA suggests that the City complete an environmental justice analysis ... to meaningfully consider the aggregate potential health effects of the proposed RMG facility on the southeast area..."
 - Michigan EGLE, September: "We encourage the company, EGLE, and local authorities to consider again whether construction at an alternative site would avoid the potential for [disproportionate] impacts."
